CURFEW

The purpose of curfew laws are

- To ensure the over all safety of minors.
- To protect the public from illegal acts of minors committed during the curfew hours.
- To protect minors from improper influences that prevail during the curfew hours, including involvement with gangs and possible drug use.
- To protect minors from criminal activity that occurs during the curfew hours.

Fort Eustis Curfew Hours:

17 years old and younger 10PM week-days (Sunday—Thursday) and 11PM Weekends (Friday & Saturday)

Exceptions to Curfew:

- If accompanied by a <u>PARENT</u> there is no curfew.
- If returning from an Instillation Sponsored or School Event, curfew applies 30 minutes after program has ended.
- Curfew does not apply when minors are legally employed and are traveling to and from place of employment.
